**ORDER**

1. By General Order 2017-3, the Bankruptcy Court for the Southern District of Texas established a Complex Case Committee to (i) review and recommend changes to the existing Procedures for Complex Chapter 11 Bankruptcy Cases; and (ii) consider and propose procedures for complex chapter 15 and chapter 7 cases as appropriate.

2. The initial members of the Complex Case Committee were appointed with no specified terms and have served continuously since the entry of General Order 2017-3. The Court expresses its appreciation to the initial members of the Complex Case Committee for their service and contribution.

3. To ensure that the Complex Case Committee functions in perpetuity with diverse input and to alleviate any burden occasioned by an unspecified term of service, the Complex Case Committee is reconstituted as follows:

4. All subsequent terms shall be for a period of two years.

5. The judges on the Complex Case Panel (General Order 2018-1) shall appoint new members to fill any vacancy created due to the expiration of a committee member's term; the resignation of a committee member; or otherwise. Nothing herein prevents a person from serving one or more consecutive terms.


6. The judges that comprise the Complex Case Panel shall serve as advisory members of the Complex Case Committee.

7. The Complex Case Committee shall have the following responsibilities:

- (i) Review and recommend changes to the existing Procedures for Complex Chapter 11 Bankruptcy Cases;
- (ii) Consider and propose procedures for complex chapter 15 and chapter 7 cases as appropriate;
- (iii) Make recommendations regarding the makeup of the Complex Case Panel; and
- (iv) Submit an evaluation of the handling of Complex Cases within the District on a semi-annual basis.

8. This Order is effective upon entry.
