**THE INDIVIDUAL ARTHUR ANDERSEN DEFENDANTS'
ANSWER TO THE AMENDED CONSOLIDATED COMPLAINT**

Defendants Michael L. Bennett, Joseph F. Berardino, Debra A. Cash, David Stephen Goddard, Jr., Gary Goolsby, Michael D. Jones, Michael M. Lowther, Benjamin S. Neuhausen, Michael C. Odom, Richard R. Petersen, John E. Stewart, and William E. Swanson ("the Individual Andersen Defendants") respectfully submit this Answer to the Class Action Amended Consolidated Complaint for Violation of the Securities Laws (the "Complaint") as follows:¹

The Individual Andersen Defendants respond generally that certain of the Individual Andersen Defendants performed auditing and accounting services relating to various entities and transactions discussed in the Complaint and, in the course of performing such services, were provided information relating to such entities and transactions in the form of representations by various Enron personnel and others and in the form of documents describing such entities and transactions. The Individual Andersen Defendants did not, however, personally form the entities at issue, nor were they parties to any of the transactions at issue, and therefore they necessarily relied on the representations and documents provided by Enron personnel and others.

The Individual Andersen Defendants have subsequently learned through the investigations of Enron and otherwise that the information provided to Andersen and the Individual Andersen Defendants was, in certain instances, materially incomplete, inaccurate, misleading and/or misrepresented. The Individual Andersen Defendants are not in a position to know at this time which representations and information provided to them were incomplete, inaccurate, misleading and/or inaccurate, and, accordingly, are unable to admit or deny in most instances the facts set forth in the Complaint relating to such entities and transactions.

1. Answering Paragraph 1, the Individual Andersen Defendants respond that this paragraph does not state an averment of fact and, as such, no response is required. 83. Answering Paragraphs 83(a)-(jj), the Individual Andersen Defendants admit that Kenneth Lay was a director and CEO of Enron at various times; that Jeffrey Skilling was a director and CEO of Enron at various times; that Andrew Fastow was CFO of Enron at various times; and that some or all of the remaining named individuals were employees or directors in various capacities for Enron or Enron-related entities. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph and its subparagraphs.

84. Answering Paragraph 84, the first sentence of this paragraph states a legal conclusion to which no response is required. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

85. Answering Paragraph 85, the Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the averments made in this paragraph.

86. Answering Paragraph 86, the Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the averments made in this paragraph.

87. Answering Paragraph 87, the Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the averments made in this paragraph.

88. Answering Paragraph 88, the Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the averments made in this paragraph.

91. Answering Paragraph 91, Andersen asserts that this paragraph does not state an averment of fact and, as such, no response is required. The Individual Andersen Defendants further respond that the Complaint speaks for itself.

92(a). Answering Paragraph 92(a), the Individual Andersen Defendants respond that the averments are vague as to “participated in,” and deny those averments on that basis. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

92(b). Answering Paragraph 92(b), the Individual Andersen Defendants respond that the averments are vague as to “participated in,” and deny those averments on that basis. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

92(c). Answering Paragraph 92(c), the Individual Andersen Defendants respond that the averments are vague as to “participated in,” and deny those averments on that basis. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

92(d). Answering Paragraph 92(d), the Individual Andersen Defendants respond that the averments are vague as to “participated in,” and deny those averments on that basis. The

Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

92(e). Answering Paragraph 92(e), the Individual Andersen Defendants reply that no response is required as this paragraph has been deleted.

92(f). Answering Paragraph 92(f), the Individual Andersen Defendants reply that no response is required as this paragraph has been deleted.

92(g). Answering Paragraph 92(g), the Individual Andersen Defendants admit that Andersen is a limited liability partnership formed under the laws of the state of Illinois and that Andersen audited Enron's financial statements for the fiscal years 1997 through 2000. The Individual Andersen Defendants respond that the averments are vague as to "consulting services," and deny those averments on that basis. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

93(a). Answering Paragraph 93(a), the Individual Andersen Defendants respond that certain averments in this paragraph use terms such as "regular," "massive," "legitimate," "instrumental," and "inappropriate" that are vague and/or argumentative, and the Individual Andersen Defendants deny those averments on that basis. The Individual Andersen Defendants admit that Berardino was the CEO and managing partner of Andersen Worldwide, and that Berardino was a partner in Andersen. Berardino admits that he resigned on March 26, 2002, and otherwise denies the remaining averments to the extent they refer or relate to him, and lacks knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph. The Individual Andersen Defendants other than Berardino lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

93(b). Answering Paragraph 93(b), the Individual Andersen Defendants admit that Bauer was a partner in Andersen, respond that the term "integral part" is vague and deny those averments on that basis, and otherwise lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

93(c). Answering Paragraph 93(c), Berardino denies the averments in this paragraph to the extent they refer or relate to him. The Individual Andersen Defendants admit that David Duncan was a partner in Andersen, that Duncan was the lead partner on the Enron engagement, and that Andersen terminated its relationship with Duncan. The Individual Andersen Defendants lack knowledge or information sufficient to form a belief as to the truth of the remaining averments made in this paragraph.

93(d). Answering Paragraph 93(d), the Individual Andersen Defendants admit Debra Cash was a partner in Andersen, and respond that the term “integral part” is vague and deny those averments on that basis. The Individual Andersen Defendants deny the remaining averments made in this paragraph.

93(e). Answering Paragraph 93(e), the Individual Andersen Defendants reply that no response is required as this paragraph has been deleted.

93(f). Answering Paragraph 93(f), the Individual Andersen Defendants admit that David Duncan was a partner in Andersen, that Duncan was the lead partner on the Enron engagement, and that Andersen terminated its relationship with Duncan. FIRST SEPARATE AND AFFIRMATIVE DEFENSE

(Failure to State a Claim)

1. The causes of action alleged in the Complaint fail to state facts sufficient to constitute a valid cause of action against the Individual Andersen Defendants. Among other things, the Complaint fails to plead fraud with particularity as required by Rule 9(b) of the Federal Rules of Civil Procedure and the Private Securities Litigation Reform Act (“PSLRA”), and fails to raise a strong inference of scienter as required by the PSLRA. The Complaint further fails to allege facts sufficient to plead that the Individual Defendants controlled Andersen for purposes of Section 20(a) of the Securities Exchange Act of 1934, as required by the PSLRA and the Federal Rules of Civil Procedure.

SECOND SEPARATE AND AFFIRMATIVE DEFENSE

(Lack of Particularity)

2. The lack of particularity in the Complaint makes it impossible for the Individual Andersen Defendants to determine at this time which additional defenses they may have, and the Individual Andersen Defendants reserve the right to assert all applicable defenses once the

precise nature of the relevant circumstances or events is determined through discovery.

THIRD SEPARATE AND AFFIRMATIVE DEFENSE

(Fraud of Others)

3. If the averments of the Complaint are true, which the Individual Andersen Defendants deny, Andersen and the Individual Andersen Defendants were victims of fraud, deceit, misrepresentations, concealment, negligence and/or breach of contract practiced upon them by others, including Enron, in that information relating to Enron and related entities was not provided to Andersen and/or the Individual Andersen Defendants and/or was knowingly concealed from Andersen and/or the Individual Andersen Defendants while Andersen and/or the Individual Andersen Defendants were rendering professional services

FOURTH SEPARATE AND AFFIRMATIVE DEFENSE

(Contribution and Indemnification)

4. Under the principles of contribution and indemnity, persons or entities other than the Individual Andersen Defendants are wholly or partially responsible for the purported damages, if any, Plaintiffs may have sustained.

FIFTH SEPARATE AND AFFIRMATIVE DEFENSE

(Intervening or Superseding Acts of Third Parties or other Defendants)

5. Plaintiffs' damages, if any, resulted from the acts or omissions of third parties or other Defendants over whom the Individual Andersen Defendants had no control. The acts of such third parties or Defendants constitute intervening or superseding causes of the harm, if any, suffered by Plaintiffs.

SIXTH SEPARATE AND AFFIRMATIVE DEFENSE

(Class Action)

6. Plaintiffs' claims against the Individual Andersen Defendants are barred because this action cannot be maintained as a class action pursuant to Rule 23 of the Federal Rules of Civil Procedure.

SEVENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Statute of Limitations)

7. Plaintiffs' claims against the Individual Andersen Defendants are barred, in whole or in part, by the applicable statutes of limitations.

EIGHTH SEPARATE AND AFFIRMATIVE DEFENSE

(Waiver)

8. Plaintiffs, by acts, omissions and/or conduct, have waived, in whole or in part, their right to obtain the relief sought in the Complaint.

NINTH SEPARATE AND AFFIRMATIVE DEFENSE

(Unclean Hands)

9. Plaintiffs' claims against the Individual Andersen Defendants are barred, in whole or in part, by the doctrine of unclean hands.

TENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Estoppel)

10. Plaintiffs, by acts, omissions, and/or conduct, are estopped, in whole or in part from obtaining the relief sought in the Complaint.

ELEVENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Adequate Remedy at Law)

11. Plaintiffs' claims for injunctive relief are barred because Plaintiffs have an adequate remedy at law.

TWELFTH SEPARATE AND AFFIRMATIVE DEFENSE

(Laches)

12. Plaintiffs' claims against the Individual Andersen Defendants are barred, in whole or in part, by the doctrine of laches.

THIRTEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Prior Knowledge)

13. At the time Plaintiffs acquired shares of Enron stock, Plaintiffs had actual or constructive knowledge of the alleged omissions or misstatements, and therefore the Individual Andersen Defendants are not subject to liability.

((

FOURTEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Failure to Mitigate Damages)

14. Plaintiffs have failed to fulfill their duty to mitigate, reduce, or otherwise avoid the alleged damages, and Plaintiffs are therefore barred from recovering such damages, if any.

FIFTEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Assumption of the Risk)

15. Plaintiffs knew that the purchase of Enron's securities involved risk and voluntarily assumed such risk.

SIXTEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Lack of Standing)

16. Plaintiffs lack standing to bring the causes of action asserted in the Complaint.

SEVENTEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Publicly Available Information)

17. Plaintiffs' claims against the Individual Andersen Defendants are barred on the ground that the matters alleged to be the subject of misrepresentations and/or omissions were publicly disclosed and/or were in the public domain, and, as such, were available to Plaintiffs and/or the securities market.

EIGHTEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Lack of Justifiable Reliance)

18. Plaintiffs' claims against the Individual Andersen Defendants are barred, in whole or in part, due to Plaintiffs' lack of justifiable reliance in that Plaintiffs did not purchase or sell any securities in reasonable or justifiable reliance on any representation, act, or omission by Andersen or the Individual Andersen Defendants.

NINETEENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Lack of Causation)

19. Plaintiffs' claims against the Individual Andersen Defendants are barred because the Individual Andersen Defendants did not directly or proximately cause or contribute to any damage, loss or injury sustained by Plaintiffs.

((

TWENTIETH SEPARATE AND AFFIRMATIVE DEFENSE

(No Aiding and Abetting Liability)

20. There is no aiding and abetting liability as set forth in *Central Bank of Denver v. First Interstate Bank of Denver*, 511 U.S. 164 (1994).

TWENTY-FIRST SEPARATE AND AFFIRMATIVE DEFENSE

(Failure to Use Due Care)

21. Plaintiffs failed to use due care in determining whether to invest in Enron and thus the Individual Andersen Defendants are not subject to liability.

TWENTY-SECOND SEPARATE AND AFFIRMATIVE DEFENSE

(Lack of Control)

22. The Individual Andersen Defendants may not be held liable under Section 15 of the Securities Act of 1933 and Section 20 of the Securities and Exchange Act of 1934 since the Individual Andersen Defendants did not have the lawful authority to control or influence Andersen within the meaning of those statutory provisions.

TWENTY-THIRD SEPARATE AND AFFIRMATIVE DEFENSE

(Reasonable Investigation)

23. With respect to any registration statement or prospectus of Enron purportedly made upon Andersen or the Individual Andersen Defendants' authority as experts or purporting to be a copy of or an extract from a report of Andersen or the Individual Andersen Defendants, Andersen and the Individual Andersen Defendants had, after reasonable investigation, reasonable grounds to believe at the time that such part of such documents became effective, that the statements therein were true and there was no omission of a material fact required therein or necessary to make the statements therein not misleading.

TWENTY-FOURTH SEPARATE AND AFFIRMATIVE DEFENSE

(No Intent to Defraud)

24. If any alleged representation of Andersen or the Individual Andersen Defendants contained any untrue statement of material fact, or omitted to state a material fact, which the Individual Andersen Defendants deny, Andersen and the Individual Andersen Defendants did not

know, and in exercise of reasonable care could not have known, of such untruth or omission, and did not act with intent to defraud the Plaintiffs, or anyone, with respect thereto.

TWENTY-FIFTH SEPARATE AND AFFIRMATIVE DEFENSE

(Failure to Join Necessary Parties)

25. The Individual Andersen Defendants affirmatively allege that Plaintiffs have failed to join necessary and indispensable parties.

TWENTY-SIXTH SEPARATE AND AFFIRMATIVE DEFENSE

(Proportional Allocation of Fault)

26. Any damage, loss or liability sustained by Plaintiffs must be reduced, diminished, and/or eliminated in proportion to the wrongful or negligent conduct of entities or individuals other than the Individual Andersen Defendants under the principles of equitable allocation, recoupment, set-off, proportionate responsibility, and comparative fault including under the proportionate liability provisions of Section 21(D)(f)(2)(B) and 21D(f)(3) of the Securities Exchange Act of 1934 and/or Chapter 33 or the Texas Civil Practice and Remedies Code.

TWENTY-SEVENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Reliance on Experts)

27. In rendering auditing and accounting services to Enron and its subsidiaries, Andersen and the Individual Andersen Defendants were entitled to and did reasonably rely on the work, conclusions and advice provided by agents of Enron and other professionals.

TWENTY-EIGHTH SEPARATE AND AFFIRMATIVE DEFENSE

(Reliance on Regulatory Authorities)

28. Plaintiffs' claims against the Individual Andersen Defendants are barred because the acts alleged were ratified or approved by the Securities and Exchange Commission and/or other state and federal regulatory agencies or entities.

TWENTY-NINTH SEPARATE AND AFFIRMATIVE DEFENSE

(Offset of Damages)

29. Any recovery for damages allegedly incurred by Plaintiffs, if any, is subject to offset in the amount of any tax benefit actually received by Plaintiffs through their investments.

((

THIRTIETH SEPARATE AND AFFIRMATIVE DEFENSE

(Lack of Impact on Market Price)

30. Plaintiffs' claims against the Individual Andersen Defendants are barred, in whole or in part, because the purported misstatements or omissions alleged in the Complaint that are attributed to Andersen and/or the Individual Andersen Defendants did not affect the market price of Enron securities.

THIRTY-FIRST SEPARATE AND AFFIRMATIVE DEFENSE

(Single Award of Damages)

31. Plaintiffs can obtain only one award of damages under either the federal securities laws or pendant state claims.

THIRTY-SECOND SEPARATE AND AFFIRMATIVE DEFENSE

(Materiality)

32. The Individual Andersen Defendants are not liable to Plaintiffs because any alleged misrepresentations or omissions for which Andersen and/or the Individual Andersen Defendants are allegedly responsible were not material.

THIRTY-THIRD SEPARATE AND AFFIRMATIVE DEFENSE

(Attorneys' Fees Not Recoverable)

33. Plaintiffs are precluded from recovering attorneys' fees from the Individual Andersen Defendants under applicable provisions of law.

THIRTY-FOURTH SEPARATE AND AFFIRMATIVE DEFENSE

(State Law Claims)

34. Plaintiffs' state law claims against the Individual Andersen Defendants are barred under the Securities Litigation Uniform Standards Act.

THIRTY-FIFTH SEPARATE AND AFFIRMATIVE DEFENSE

(Claims Non Actionable under PSLRA)

35. The claims alleged in the Complaint are non-actionable to the extent that the alleged untrue statements of material fact, omissions of material fact, misleading statements, and/or other challenged statements made by Defendants fall within the Safe Harbor provisions of

the Private Securities Litigation Reform Act.

THIRTY-SIXTH SEPARATE AND AFFIRMATIVE DEFENSE

(Good Faith)

36. If Andersen is liable for violations of the securities laws, which the Individual Andersen Defendants deny, the Individual Defendants are not liable as control persons under Section 20 of the Securities Exchange Act of 1934 because they acted in good faith and did not directly or indirectly induce the act or acts constituting such violation or cause of action.

THIRTY-SEVENTH SEPARATE AND AFFIRMATIVE DEFENSE

(Additional Defenses)

37. The Individual Andersen Defendants hereby adopt and incorporate by reference any and all other defenses asserted, or that may hereafter be asserted, by any other defendant to the extent such defense may be applicable to the Individual Andersen Defendants.

WHEREFORE, the Individual Andersen Defendants seek judgment:

- A. dismissing with prejudice all claims asserted against the Individual Andersen Defendants;
- B. awarding the costs of defending this action, including reasonable attorneys' fees, costs and disbursements; and
- C. granting such other and further relief as this Court may deem just and proper.

THE INDIVIDUAL ANDERSEN DEFENDANTS REQUEST A TRIAL BY JURY
