**AGREED MOTION FOR EXTENSION OF DEADLINES FOR MOTIONS
SEEKING CONFIDENTIAL TREATMENT OF CERTAIN DOCUMENTS**

TO THE HONORABLE MELINDA HARMON, UNITED STATES DISTRICT JUDGE:

The Lead Plaintiff and Defendants J.P. Morgan Chase & Co., J.P. Morgan Securities, Inc., JP Morgan Chase Bank, Citigroup Inc., Citibank N.A., Citigroup Global Markets Inc., Citigroup Global Markets Ltd., Credit Suisse First Boston LLC (formerly known as Credit Suisse First Boston Corporation), Credit Suisse First Boston (USA), Inc., Pershing LLC, Canadian Imperial Bank of Commerce, CIBC World Markets plc, CIBC World Markets Corp., f/k/a CIBC Oppenheimer Corp., Bank of America Corporation, Banc of America Securities LLC, Merrill Lynch & Co., Inc., Merrill Lynch, Pierce, Fenner & Smith Incorporated, Barclays PLC, Barclays Bank PLC, Barclays Capital Inc., Lehman Brothers Inc. and Lehman Brothers Holdings

Inc. (collectively, the "Bank Defendants") file this request for extension of the deadlines for filing motions seeking confidential treatment of certain documents, and respectfully show the Court as follows:

1. On September 18, 2003, the Court entered an order on an agreed motion of the Lead Plaintiff and the Bank Defendants providing that any Bank Defendant wishing to file a confidentiality motion with respect to any documents or written discovery produced on or before October 1, 2003 must file such motion on or before October 15, 2003.

2. Lead Plaintiff and the Bank Defendants have agreed that, in order to allow the parties additional time to confer in an effort to reach agreement on issues of confidentiality, the deadline for making any motion seeking confidential treatment for documents or written discovery produced on or before October 1, 2003 should be extended through and including November 3, 2003 and that any opposition by Lead Plaintiff to such confidentiality motions shall be filed on or before December 15, 2003.

3. Lead Plaintiff and the Bank Defendants have agreed that the restrictions in paragraph 1 of the Order of September 18, 2003 shall remain in effect until November 4, 2003 for all documents and written discovery produced on or before October 1, 2003 as to which no confidentiality motion is made and shall remain in effect until the Court enters a decision resolving confidentiality motions for documents and written discovery as to which such motions are made.

4. Lead Plaintiff and the Bank Defendants have agreed that the provisions of paragraphs 5 and 6 of the Order of September 18, 2003 shall remain in effect.

WHEREFORE, Lead Plaintiff and the Bank Defendants request that the deadlines for the Bank Defendants to file any motion seeking confidential treatment of certain documents and the deadline for the Lead Plaintiff to respond to any such motions be extended as described in this agreed motion.


