**UNOPPOSED MOTION OF CIBC DEFENDANTS FOR AN EXTENSION OF TIME
TO RESPOND TO LEAD PLAINTIFFS' MOTION TO COMPEL**

Defendants Canadian Imperial Bank of Commerce and CIBC World Markets Corp.
(collectively "CIBC Defendants") respectfully submit this unopposed motion for an order
extending until July 20, 2004, the time for the CIBC Defendants to file their response to the
Motion to Compel (Docket No. 2183) filed by Lead Plaintiffs.

In support of the Unopposed Motion, the CIBC Defendants respectfully show the Court
the following:

1. Counsel for the CIBC Defendants and Lead Plaintiffs have been working together to attempt to resolve by agreement the issues raised in Lead Plaintiffs' Motion to Compel. Those discussions have been productive, but are not yet complete.

2. Counsel for the CIBC Defendants and Lead Plaintiffs have previously agreed to extend the time for the CIBC Defendants to respond to the Motion to Compel until June 30, 2004. The parties continue to make progress toward resolving their issues consensually; however, additional time is required.

3. This second, limited extension is warranted due to the complexity and burdens of the case and will not delay the proceedings, but rather will serve the interests of justice and promote efficiency.

Accordingly, the CIBC Defendants respectfully request that the Court enter the Order submitted with this Unopposed Motion extending the time for the CIBC Defendants to respond to the Motion to Compel until July 20, 2004.


