Admission Requirements Southern District of Texas

- *Eligibility*: To apply for admission, you must be licensed to practice law by the licensing authority of one of the fifty states, the District of Columbia, or a Territory of the United States, and if licensed by a licensing authority other than the State of Texas, then an attorney must also be a member in good standing of a United States District Court (Local Rule 83.1(A)).
- *Steps*: You must apply on the court's form and pay the fee. You must attend an approved workshop and take the oath from a judicial officer.
- *Workshop*: Applicants must attend a workshop, unless they:
 - a. Have reached the age of seventy.
 - b. Reside out of the district and are a member of the bar of another United States District Court and have filed an original certificate of good standing from it (dated within the last 90 days), and an executed Oath.
 - c. Are a former circuit, district, bankruptcy, or magistrate judge.
 - d. Are a Texas State Bar member who has completed the current <u>Federal Court</u> <u>Practice Seminar</u> (online CLE offered by the State Bar of Texas.) and provide proof of completion with their application.

CLE credit of 1.5 hours, which includes 0.5 of ethics, will be given for attending the workshop. Workshops are generally held on the second Thursday of February, May, August and November. To guarantee admittance to a workshop, your application must be received 14 days prior to the workshop.

Applications are submitted, including payment of admission fee, using our CM/ECF Document Filing System by following the instructions on the Southern District of Texas Attorney Admissions Requirements webpage.
