

**COURT PROCEDURES  
MARVIN ISGUR  
UNITED STATES BANKRUPTCY JUDGE**

**1. Applicable Rules.**

Practice in this Court will be governed by the Federal Rules of Bankruptcy Procedure, the Local Rules of the United States Bankruptcy Court for the Southern District of Texas, and these Court Procedures.

All parties appearing before the Court are charged with responsibility for compliance with applicable rules.

**2. Telephonic Participation/Live Viewing of Court Documents During Hearings.**

You will be responsible for your own long-distance charges. The dial-in number should be used regardless of the location of the hearing (Houston, Brownsville, Corpus Christi, Galveston or McAllen).

You will be asked to key in the conference room number. The conference room number is **815978**. Once this number is entered, you will be connected live to the courtroom.

If a technological problem arises, the hearing will continue without the participation of dial-in participants. The Court will not delay hearings for signal problems or interference. Accordingly, persons choosing to attend a hearing by dial-in do so at their own risk of a technological failure.

**Instructions**

- a.** Dial in at least 5 minutes before your hearing is scheduled to begin.
- b.** Parties are always permitted to participate by dial-in without any permission or notification to the Court except:
  - i.** Dial-in participation is not allowed for chapter 13 panel hearings.
  - ii.** Witnesses may not be presented by dial-in and witnesses may not be examined by telephone, except in emergency situations if the Court determines to waive this prohibition for good cause.

- iii. Parties may not participate by cell phone but may listen to hearings from their cell phone.
- c. Parties may not participate by speakerphone.
- d. Do not place your telephone on hold. You may mute your phone. If you dial in to a hearing, you are participating in a court proceeding and are bound by the normal rules of courtesy and attention.
- e. If a technological problem arises, the hearing will continue without the participation of dial-in participants. The Court will not delay hearings for signal problems or interference. Accordingly, persons choosing to attend a hearing by dial-in do so at their own risk of a technological failure.
- f. The following procedures must be used for dial-in participation.
  - i. The dial-in number is **1-712-775-8925**. Please note the **712** area code.
  - ii. You will be responsible for your own long-distance charges. The dial-in number should be used regardless of the location of the hearing (Houston, Brownsville, Corpus Christi, Galveston or McAllen).
  - iii. You will be asked to key in the conference room number. The conference room number is **815978**. Once this number is entered, you will be connected live to the courtroom.
  - iv. Once you are connected, you will be able to hear persons speaking in the courtroom and other persons on the call addressing the Court. You will not be able to address the Court until the Court addresses you or you request to speak and the Court grants the request.
  - v. If you wish to address the Court, you must press 5\*. Do not press 5\* until you need to address the Court. Within 5 seconds, the Court will receive a signal that you wish to speak. When the Court calls on you, you will hear a recorded message that your line has been unmuted. At that time, you can be heard.
  - vi. When you are done, the Court will ordinarily may leave your line active. If your line is muted, you will hear a recorded message that your line has been muted. You may press 5\* if an additional issue arises that you wish to address with the Court.
  - vii. Telephonic participants may connect on-line to view the Court's broadcast onto the courtroom's television monitors. To view on-line, you may connect through the website located at <https://www.join.me>. Click on "Join Meeting". The code for the meeting is "judgeisgur". If you are attempting to view the broadcast on an

IPAD or similar device, you may be required to download a free app from the website.

### **3. Contact with Court and Court Personnel.**

Communications with the Court should be in the form of pleadings filed with the clerk of the Court. Attorneys and parties who are not represented by counsel may contact the Court's case manager: **Linhthu Do** at [linhthu\\_do@txs.uscourts.gov](mailto:linhthu_do@txs.uscourts.gov) or **(713) 250-5421**. If Ms. Do is out of the office and you have an emergency, please contact the relief case manager: **Ruben Castro** at [ruben\\_castro@txs.uscourts.gov](mailto:ruben_castro@txs.uscourts.gov) or **(713) 250-5449**. Directing routine questions to the relief case manager may result in further delay as these are usually forwarded to the case manager.

Contact with Judge Isgur and his law clerks, other than by pleadings, is strictly prohibited. Letters and telephone calls to chambers concerning cases are prohibited.

Courtesy copies and other communications by mail should be directed to the case manager, Linhthu Do, at **U.S. Bankruptcy Court, ATTENTION: Linhthu Do, Bob Casey U.S. Courthouse, 515 Rusk, Houston, TX 77002**. Sending communications through chambers may delay the process.

The case manager and relief case manager are unable to answer CM/ECF filing questions. Please contact the Helpdesk at (866) 358-6201 for technical assistance, including login problems, blank screens, attachments, errors in document filings, etc.

Transcripts may be requested from the Electronic Recording Office at (713) 250-5404. Please contact the ERO to request both paper and compact disc transcripts. The case manager cannot take transcript orders.

### **4. Attendance at Hearings.**

Unless otherwise set forth in the local rules, these procedures, or an order by this Court, a person with authority to bind the client must attend each hearing. For parties represented by an attorney, this will generally be an attorney with full authority to act on the matter before the Court. If a client represented by counsel does not give full authority to the counsel who will appear, a representative of the client with full authority on the matter to be considered should accompany the counsel to the hearing.

### **5. Obtaining Settings for Hearings.**

Hearings will be set in one of the following ways:

**a.** Hearings may be set by self-calendaring in the electronic filing system (CM/ECF). When a motion is filed in the Court's electronic filing system, the system will prompt the selection of a date for a hearing. Only a date that is listed as an available date on the Court's website should be selected. You must select a date that is at least 23 days from the date that you file a motion. *If you do not need a hearing, this step may be skipped.* Routinely, only opposed

motions need to be set for a hearing. All motions for relief from stay (§ 362), however, must be set for a hearing. **YOU MAY NOT SELF-CALENDAR A HEARING ON A DATE THAT IS NOT LISTED AS AN AVAILABLE DATE. AVAILABLE DATES CHANGE FREQUENTLY. EVEN IF A PRIOR MOTION WAS SELF-CALENDARED FOR A PARTICULAR DATE, YOU MAY NOT SELF-CALENDAR A HEARING UNLESS THE DATE IS SHOWN AS AN AVAILABLE DATE AT THE TIME THAT YOU FILE THE MOTION.**

**b.** Notice of the date of a hearing must be provided by the movant and a certificate of service must be filed. If a motion is self-calendared, notice of the hearing date must be provided when the motion is served and a certificate of service must be included with the motion. If the date is set by the Court, notice must be given within 2 business days and a certificate of service must be filed.

**c.** If the Court schedules an emergency hearing, the party requesting the hearing must immediately give actual notice to opposing parties. Actual notice may be by telephone, e-mail, or facsimile. Mailed notice is not adequate.

**d.** If a date is not selected through the self-calendaring system and the Court is unable to rule without a hearing, the Court will direct the clerk to set a hearing.

**e.** If the Court has not ruled on a motion within 35 days, parties should contact the Court’s case manager at **linhthu\_do@txs.uscourts.gov** or **(713) 250-5421** to inquire about the status of the motion. Absent emergency consideration and with few exceptions, e.g., motion for continuance, motion to use cash collateral, etc., motions are not considered until at least 22 days after submission and are frequently not ruled on for another 10 days.

**6. Continuances.**

A continuance can only be requested by motion. The Court may deny a continuance even if all parties have agreed to the continuance. If a motion for continuance is pending, attendance is not excused. If a proposed agreed order has been filed, paragraph 11 of these procedures controls.

**7. Fee Applications in cases under chapter 7.**

Applications for compensation and reimbursement in cases under chapter 7 must contain the following information. If additional information is required, the Court will request a supplement:

- A. A table containing the following information, which shall begin on the first page of the application:

### 8. Fee Applications in cases under chapters 11 or 12.

Applications for compensation and reimbursement in cases under chapters 11 or 12 must contain the following information. If additional information is required, the Court will request a supplement:

A. A table containing the following information, which shall begin on the first page of the application:

**9. Fee Applications in cases under chapter 13.**

Pursuant to the local rules on fee applications, approved *fixed fee applications* do not require the filing of subsequent applications. Otherwise, applications for compensation and reimbursement in cases under chapter 13 must contain the following information. If additional information is required, the Court will request a supplement:

- A. A table containing the following information, which shall begin on the first page of the application:

## 10. Discovery Disputes.

Discovery disputes that cannot be resolved between the parties should ordinarily be submitted by written motion. However, if a dispute arises during an oral deposition, a party may contact the Court's case manager at 713-250-5421 during the deposition and request a telephonic hearing with the Court.

The Court intends to enforce Federal Rule of Civil Procedure 37 as made applicable to proceedings in this Court by Federal Rule of Bankruptcy Procedure 7037.

## **11. Settlements.**

Settlements are always encouraged. If a case is settled, the parties should promptly contact the Court's case manager at 713-250-5421. The proposed settlement should be presented in the form of a written order at the scheduled hearing. If the proposed settlement has been approved in writing by all parties, then only one counsel is required to attend the hearing, though all interested parties are invited to attend. If the Court does not approve of the proposed settlement, the hearing will be reset for a subsequent date.

However, if a settlement is signed by the Court prior to the hearing, the hearing will be canceled. Only when an order is signed and docketed should it be assumed that the hearing will be canceled.

If a settlement is in an adversary proceeding and requires approval pursuant to Federal Rule of Bankruptcy Procedure 9019, the 9019 motion should be filed in the main case only. A proposed form of order in the main case and a proposed form of judgment or order in the adversary proceeding should be attached to the 9019 motion.

## **12. Proposed Orders.**

*Proposed forms of orders are to be uploaded in CM/ECF prior to hearings.*

Proposed forms of orders must be submitted along with all motions and with all oppositions to motions.

Please consult the local rules in the Southern District of Texas regarding the treatment of proposed agreed orders.

Parties may only request that a signed order be amended through filing a *motion to amend*. Merely submitting a proposed amended order is insufficient. The motion to amend should be filed with the proposed amended order. These will then be submitted to chambers following the 22-day submission period.

## **13. Courtesy Copies.**

### **Pleadings and Motions**

For those pleadings and motions electronically filed in CM/ECF, courtesy copies are neither required nor necessary.

### **Exhibits**



Regardless of the format or manner of exchange utilized by counsel, 2 paper copies of exhibits are required by the Court at the hearing, and may be handed up to the courtroom deputy shortly before the start of the hearing.

Courtesy copies of exhibits may be delivered in advance of any hearing. Please deliver courtesy copies of exhibits to the Court's case manager, Linhthu Do. Ms. Do's office is on the Fourth Floor of the United States Courthouse in Houston. Courtesy copies may be hand delivered. Contact Ms. Do prior to delivery of the documents to arrange for her availability. She may be contacted at 713-250-5421.

#### **14. Courtroom Technology.**

The courtroom is equipped with technology that will allow parties to broadcast exhibits and other documents to opposing parties, witnesses and the Court from the display output on most laptop computers. Paper copies of exhibits may also be broadcast from a document projector located in the courtroom. *However, 2 paper copies of exhibits are still required by the Court, regardless of the format or manner of exchange utilized by counsel.*

Parties may also broadcast video and sound from a laptop computer to monitors throughout the courtroom.

The courtroom is equipped with wireless internet access (Wi-Fi). Instructions for utilizing this technology are available outside the courtroom and on the Court's website.

Any additional technology requirements must be arranged on adequate advance notice with the case manager or relief case manager.

Parties are strongly encouraged to utilize the technology available in the courtroom. If parties would be more comfortable testing the broadcast or other technology prior to the hearing or trial, please confer with the courtroom deputy and be mindful of the Court's schedule. Time permitting, the courtroom deputy will help parties test equipment if requested, but interruption of another proceeding is not permitted.
