AMENDED 2015 WORK ORDER

Adjustments to the Division of Work Order No. 2015-1 are necessary due to the appointment of Eduardo Rodriguez as a United States Bankruptcy Judge. Under 28 U.S.C. § 154, the judges are assigned these matters, effective July 31, 2015.

**1. Judge Letitia Z. Paul.**

- a. Retention of all bankruptcy cases and adversary proceedings presently on Judge Paul's docket.
- b. 13.2% of all Chapter 7 bankruptcy cases filed in the Houston Division.
- c. 14% of all Chapter 11 bankruptcy cases filed in the Houston Division, except Chapter 11 cases assigned by virtue of the Complex Chapter 11 Case procedure.
- d. 20% of all Complex Chapter 11 bankruptcy cases filed in the Houston Division.
- e. 17.4% of chapter 13 cases filed in the Houston Division.
- f. 20% of all Chapter 15 bankruptcy cases filed in the Houston Division.
- g. 100% of all adversary proceedings filed in the Houston Division that arise in, under or relate to bankruptcy cases assigned to Judge Paul.
- h. 20% of all adversary proceedings filed in the Houston Division that do not arise in, under or relate to any case pending in the Houston Division.
- i. 100% of all bankruptcy cases and adversary proceedings filed in the Galveston Division.

**2. Judge Karen K. Brown**

- a. Retention of all bankruptcy cases and adversary proceedings presently on Judge Brown's docket.
- b. 21.7% of all Chapter 7 bankruptcy cases filed in the Houston Division.
- c. 21.5% of all Chapter 11 bankruptcy cases filed in the Houston Division, except Chapter 11 cases assigned by virtue of the Complex Chapter 11 Case procedure.

- d. 20% of all Complex Chapter 11 bankruptcy cases filed in the Houston Division.
- e. 21.7% of chapter 13 cases filed in the Houston Division.
- f. 20% of all Chapter 15 bankruptcy cases filed in the Houston Division.
- g. 100% of all adversary proceedings filed in the Houston Division that arise in, under or relate to bankruptcy cases assigned to Judge Brown.
- h. 20% of all adversary proceedings filed in the Houston Division that do not arise in, under or relate to any case pending in the Houston Division.

**3. Judge Marvin Isgur**

- a. Retention of all bankruptcy cases and adversary proceedings presently on Judge Isgur's docket.
- b. 21.7% of all Chapter 7 bankruptcy cases filed in the Houston Division.
- c. 21.5% of all Chapter 11 bankruptcy cases filed in the Houston Division, except Chapter 11 cases assigned by virtue of the Complex Chapter 11 Case procedure.
- d. 20% of all Complex 11 cases filed in the Houston Division.
- e. 21.7% of chapter 13 cases filed in the Houston Division.
- f. 20% of all Chapter 15 cases filed in the Houston Division.
- g. 100% of all Chapter 12 bankruptcy cases filed in the Houston Division.
- h. 100% of all adversary proceedings filed in the Houston Division that arise in, under or relate to bankruptcy cases assigned to Judge Isgur.
- i. 20% of all adversary proceedings filed in the Houston Division that do not arise in, under or relate to any case pending in the Houston Division.
- j. All cases and adversary proceedings filed in the Brownsville and McAllen Divisions in which Judge Rodriguez previously appeared as counsel.
- k. 100% of all Chapter 13 bankruptcy cases pending or filed in the Corpus Christi Division.
- l. 50.0% of all Chapter 11 bankruptcy cases filed in the Corpus Christi Division.
- m. 100% of all adversary proceedings filed in the Corpus Christi Division that arise in, under or relate to bankruptcy cases assigned to Judge Isgur.

**4. Judge Jeff Bohm**

- a. Retention of all bankruptcy cases and adversary proceedings presently on Judge Bohm's docket.
- b. 21.7% of all Chapter 7 bankruptcy cases filed in the Houston Division.
- c. 21.5% of all Chapter 11 bankruptcy cases filed in the Houston Division, except Chapter 11 cases assigned by virtue of the Complex Chapter 11 Case procedure.
- d. 20% of all Complex Chapter 11 bankruptcy cases filed in the Houston Division.
- e. 21.7% of chapter 13 cases filed in the Houston Division.
- f. 20% of all Chapter 15 bankruptcy cases filed in the Houston Division.
- g. 100% of all adversary proceedings filed in the Houston Division that arise in, under or relate to bankruptcy cases assigned to Judge Bohm.
- h. 20% of all adversary proceedings filed in the Houston Division that do not arise in, under or relate to any case pending in the Houston Division.

**5. Chief Judge David Jones**

- a. Retention of all bankruptcy cases and adversary proceedings presently on Judge Jones's docket.
- b. 21.7% of all Chapter 7 bankruptcy cases filed in the Houston Division.
- c. 21.5% of all Chapter 11 bankruptcy cases filed in the Houston Division, except Chapter 11 cases assigned by virtue of the Complex Chapter 11 Case procedure.
- d. 20% of all Complex Chapter 11 bankruptcy cases filed in the Houston Division.
- e. 17.4% of chapter 13 cases filed in the Houston Division.
- f. 20% of all Chapter 15 bankruptcy cases filed in the Houston Division.
- g. 100% of all adversary proceedings filed in the Houston Division that arise in, under or relate to bankruptcy cases assigned to Judge Jones.
- h. 20% of all adversary proceedings filed in the Houston Division that do not arise in, under or relate to any case pending in the Houston Division.
- i. 100% of all bankruptcy cases and adversary proceedings filed in the Laredo and Victoria Divisions.
- j. 100% of all Chapter 7, 9, 12 and 15 bankruptcy cases pending or filed in the Corpus Christi Division.

- k. 100% of all Chapter 11 cases pending in the Corpus Christi Division.
- l. 50.0% of all Chapter 11 bankruptcy cases filed in the Corpus Christi Division.
- m. 100% of all adversary proceedings filed in the Corpus Christi Division that arise in, under or relate to bankruptcy cases assigned to Judge Jones.
- n. 100% of all adversary proceedings filed in the Corpus Christi Division that do not arise in, under or relate to any case pending in the Corpus Christi Division.
- o. All statutory duties of chief judge for the district.


**6. Judge Eduardo Rodriguez**

- a. 100% of all bankruptcy cases and adversary proceedings filed in the Brownsville and McAllen Divisions except those cases in which Judge Rodriguez previously appeared as counsel.

**7. All Judges**

- a. On motion of a party in interest or on its own motion, the judge may transfer a case, an adversary proceeding, or a contested matter to another judge in this district. Any recusals will be randomly assigned to another judge within the division, or if the division is a single-judge division, to another judge within the district. When a judge recuses from hearing a Chapter 13 Houston case, the Clerk will confine the random reassignment process to the remaining judges to whom the case trustee is assigned.
- b. Applications for temporary restraining orders, preliminary injunctions, and similar emergency matters will be considered by the judge to whom the bankruptcy case is assigned. If that judge is not available and the emergency requires prompt action, the matter may be considered by any available bankruptcy judge.
- c. These arrangements do not deprive a bankruptcy judge of jurisdiction of any case, proceeding, or matter, but they are made to expedite the disposition of cases. A bankruptcy judge may try cases and handle other matters for another bankruptcy judge by agreement of the judges.
