In as in any contested case, the penalty to be assessed will be determined by the Magistrate or Judge of the United States District Court and may include a term of imprisonment of not more than six months.

These collateral amounts are promulgated in accordance with 38 C.F.R. 1.218 and 18 U.S.C. SS 13. References to Articles are references to Texas Revised Civil Statutes (Vernon's).
