ORDER OF RECALL

The Honorable Robert C. McGuire, of the Northern District of Texas has consented to serve as a recalled bankruptcy judge pursuant to the regulations promulgated by the Judicial Conference of the United States.

IT IS ORDERED, pursuant to 28 U.S.C. § 155(b), that Robert C. McGuire is recalled into service as a United States Bankruptcy Judge in the Southern District of Texas for the period June 1, 2004 through February 28, 2005, or until a successor to Chief Judge William R. Greendyke is appointed, whichever occurs first. Judge McGuire is authorized to possess all powers and conduct all duties of an active bankruptcy judge.

IT IS FURTHER ORDERED that Robert C. McGuire shall receive the salary of a full-time bankruptcy judge, subject to the restrictions on the payment of an annuity in subchapter III of Chapter 83 of Title 5 of the United States Code. During the recall, the Council authorizes the continued employment of former Chief Judge William R. Greendyke's staff of one law clerk and one secretary.


