*Note 1: "Treatment facility" is defined broadly to include any facility that offers or purports to offer treatment ("planned, structured, and organized program designed to initiate and promote a person's chemical-free status or to maintain the person free of illegal drug"). Thus a treatment facility may include the following facilities: a public or private hospital; a detoxification facility; a primary care facility; an intensive care facility; a long-term care facility; an outpatient care facility; a community mental health center; a health maintenance organization; a recovery center; a halfway house; an ambulatory care facility; or any other facility offering treatment.

*Note 2: DSHS regulates certain equipment used in the radiology process, but does not per se license mammography clinics.
